BOARD OF COMMISSIONERS
Monday, January 8, 2024

Mayor Dale Sowers called the meeting to order at 6:30 pm. Members present: Commissioners Dan Taylor, Walter Vinson, Sonny Mason and David Bragg. Commissioner Quinn was absent.

A motion was made by Commissioner Mason to excuse Commissioner Quinn from the Board of Commissioners meeting Monday, January 8, 2024. There was no second to the motion; motion failed.

A motion was made by Commissioner Vinson to approve the December 4, 2023 minutes. The motion was seconded by Commissioner Bragg and passed unanimously (4 to 0).

He suggested that the board members look over and make any changes suitable for the Town to use when doing their ordinance. He also stated that Cameron Watson is interested in being the animal control person.

f. **Mayor's Report** – Mayor Sowers asked Commissioner Bragg if he would continue as the Street Commissioner and Commissioner Bragg agreed.

Mayor Sowers asked Commissioner Taylor if he would continue as Utilities Commissioner and Commissioner Taylor agreed.

Mayor Sowers asked Commissioner Vinson if he would like to take over the position as Budget Officer. Commissioner Vinson accepted.

Mayor Sowers stated that since Commissioner Mason had the most votes in the current election, he would be the new Mayor ProTem.

Mayor Sowers also asked the Board about Christmas lights throughout the Town. We would need 4 to 6 lights (\$600 per light; \$200 per hookup). Cedar Point will put up and take down. The Board decided to hold off on Christmas lights at this point.

He also mentioned the sign for Peletier. The Board agreed to move forward with the sign. Sign will be included in the new budget.
